- Entries will be limited to Twenty (20) teams on a first come basis.
- Teams are to check in with the BBQ Contest Coordinator upon arrival on-site for set up location.
- All uncooked meat shall be inspected prior to any seasoning, injection or cooking.
- All Meat must be raw, non-marinated and in original packaging. Meat inspections will be conducted prior to initiating any marinating, injection, seasoning or cooking.
- Teams are required to cook within their assigned 20 ft. x 20ft. space.
- Team Entry fee is \$125.00 per team and sample meat requirements listed below.
- Contestant agrees to comply with event rules and judging procedures.
- Cleaning and disinfection of the cook site and sample tables are paramount for the safety of the public.
- All cook sites must be cleaned and vacated by 7:00 PM.
- No food items are to be sold to the public by BBQ Teams during this event.
- Distribution of \$1,500.00 Prizes will be performed at the end of the awards program.

Sample Meat Requirements for judging and people’s choice voting: This is a minimum recommended amount of meat used for the event, but the more BBQ samples you provide to the attendees = more votes for your team.

- PORK: Four (4) / (6 to 7 LB) pork shoulder /Butt roast for judging and public samples.
- CHICKEN: (of choice) finished chicken of choice for judging.
- BRISKET: for judging.
- **Each team will be provided four (4) additional free pork butts after Captains Meeting to help reduce costs and provide additional meat for sample purposes.**
